Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER), which provides key information on the 2023-24 educational progress for Boyne Falls Public School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2024-25 school year, schools were identified based on previous years' performance using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that had at least one underperforming student subgroup in 2023-24. An Additional Targeted Support (ATS) school is one that had a student subgroup performing at the same level as the lowest 5% of all schools in the state in 2021-22. A Comprehensive Support and Improvement (CSI) school is one whose performance was in the lowest 5% of all schools in the state, had a graduation rate at or below 67%, or failed to exit ATS status in 2021-22. Some schools are not identified with any of these labels. In these cases, no label is given. Our school has not been given one of these labels.

Our school district continues to work on strengthening the partnership between our students' homes and our classrooms. We are seeing great results when our students continue to work on academic pursuits while at home. Those who rely solely on the time spent in school during the school day, may continue to struggle to close the achievement gaps.

- Process for assigning pupils to the school: Boyne Falls students are all assigned to the same school.
- The status of the 3-5 year school improvement plan: Boyne Falls meets several times per year to discuss the K-12 school improvement plan. Currently, we continue to work on improving our understanding of math concepts and focus on school culture and climate.
- A brief description of each specialized school: We have no specialized schools in Boyne Falls.
- Identify how to access a copy of the core curriculum, a description of its implementation, and an explanation of the variances from the state's model: Boyne Falls curriculum is based on state and national standards and can be accessed through the school office.
